Well in a court you have moved from the LAWFUL jurisdiction to the LEGAL jurisdiction and there is a world of a difference as you will see.

You are human, your made of flesh and blood and you are called Joe of the family of Bloggs but you also have a strawman, made not out of flesh and blood but a legal entity, a created fictional character, he's like a little counter, something like the top hat or the racing car when you're playing monopoly, you play the game but you move the counter around the board. He has a name too, it's the same as your name but it's ALWAYS WRITTEN IN CAPITALS AND IT ALWAYS HAS MR. MRS.
